RESOLUTION 2014-02

A RESOLUTION OF THE COMMISSIONERS OF ST. MICHAELS TO AUTHORIZE THE SUBMISSION OF AN APPLICATION FOR FUNDING FROM THE STATE OF MARYLAND, DEPARTMENT OF HOUSING AND COMMUNITY DEVELOPMENT, COMMUNITY BLOCK GRANT FUNDS (CDBG), IN THE AMOUNT OF \$600,000.00 (SIX HUNDRED THOUSAND DOLLARS), THE SUB-RECIPIENT OF THE FUNDING TO BE THE ST. MICHAELS COMMUNITY CENTER; SAID GRANT TO FUND ACQUISITION OF THE PROPERTY AND STRUCTURES CONTAINING THE ST. MICHAELS COMMUNITY CENTER, LOCATED AT 103 RAILROAD AVENUE; ACQUISITION WILL PERMIT THE PERMANENT LOCATION OF THE COMMUNITY CENTER.

WHEREAS, the State of Maryland through the Department of Housing and Community Development has solicited applications from eligible jurisdictions to apply for funding under the Maryland Community Development Block Grant (CDBG) Program; and

WHEREAS, The Town of St. Michaels is eligible to apply for funds from the State of Maryland, Department of Housing and CDBG Funds; and

WHEREAS, The Commissioners of St. Michaels have held the required public hearing(s) related to the formulation of the Town of St. Michaels' Block Grant Application.

NOW THEREFORE BE IT RESOLVED, that A. Michael Vlahovich, President of the Commissioners of St. Michaels, is authorized and empowered to execute any and all documents required for the submission of the application; and

BE IT FURTHER RESOLVED that this Resolution shall take effect upon the date of its adoption.
